



ARTICULATION AGREEMENT

BETWEEN

**State University College of Technology at Delhi
(SUNY Delhi)**

and

**Suffolk County Community College
Effective Date Spring 2019**

The SUNY Delhi agrees to articulate with Suffolk County Community College by providing opportunities for appropriately qualified students to complete SUNY Delhi's Online Bachelor of Science in Nursing program. Students selected for matriculation in this program will, upon satisfactory completion of the following, can continue their studies at the SUNY Delhi.

While admission to the SUNY Delhi is competitive, students satisfying the following will be accepted with full junior status:

1. Cumulative GPA of 2.8 or above for prerequisite credits
2. Graduation from an accredited Associate Degree in Nursing program
3. Current RN license (within six months of graduation)
4. Nursing coursework grades must be a C+ or better. All liberal arts and science courses must be a C or better. Required courses include Anatomy and Physiology I & II, Microbiology, English, and Psychology

**Pre-advisement for Statistics or equivalent is recommended.*

**Students can apply prior to graduation and will be considered for admissions, if verified by the Associate Dean of Nursing and Health Career Programs at Suffolk Community College. A final college transcript with graduation date is required at the time of graduation.*

**Students have up to six months to pass their NCLEX*

This articulation is based on the following inter-institutional agreements:

1. SUNY Delhi will provide financial aid support to matriculated students that qualify for financial aid.

2. Interested students must submit an application for admission, along with official college transcripts as required by the Enrollment Services Office at the SUNY Delhi.
3. SUNY Delhi advisors will assume responsibility for advising students who are covered by this agreement. SUNY Delhi curriculum fact sheets will be used as the mechanism for communicating degree requirements to students.
4. Misty Fields, Associate Director of Admissions will be the designated contact persons and coordinator of this agreement for SUNY Delhi. Cheryl Shaffer, Associate Dean of the Nursing and Health Career Programs will be the designated contact person for Suffolk County Community College. Both parties agree to act as agents responsible for implementing this agreement, identifying and incorporating any changes into subsequent agreements, communicate changes to prospective faculty members, advisors, counselors, and others to whom the information is pertinent.
5. Should either party desire to terminate this ARTICULATION AGREEMENT, notification shall be given to the other party in writing not less than six (6) months prior to the proposed date of termination.
6. The SUNY Delhi will supply Suffolk County Community College with promotional and informational literature, which will be used to assist students, faculty, and staff.
