Principal Articulation Agreement Between

MANHATTAN UNIVERSITY

And

SUFFOLK COUNTY COMMUNITY COLLEGE

This Principal Articulation Agreement ("Agreement") between Manhattan University (herein "MU") and Suffolk County Community College (herein "SCCC") will serve as a guiding document for use by students and administrators of both institutions in understanding the academic relationship between the schools.

Purpose

Suffolk County Community College, a community college established pursuant to the New York State Education Law, under the sponsorship of the County of Suffolk, in the program of the State University of New York, and Manhattan University, an education corporation chartered by the New York State Board of Regents located in Riverdale, New York, agree to articulate the programs outlined in the appendix of this document to ensure a smooth transfer process for SCCC graduates to Manhattan University.

The purpose of this Agreement is to formalize a 2+2 Combined A.A./A.S. and B.A./B.S. Degree Program between the parties. The 2+2 Program enables graduates of Suffolk County Community College to become third-year students at Manhattan University after completing the total number of credit hours required by SCCC for the award of an associate's degree. Following the successful completion of two years of course work at Manhattan University, students will be awarded the B.A. or B.S. degree, granting credit for the final two years of the bachelor's degree based on successful completion of the associate's degree.

The objective of this Agreement is to strengthen ties between the Parties and to promote academic cooperation that will ultimately benefit both institutions.

Admission

This Agreement applies to students who have completed an associate's degree at Suffolk County Community College and meet Manhattan University admission requirements for their program of study. Unless otherwise indicated, SCCC associate's degree holders with a 2.5 cumulative GPA or higher will be admitted to most programs at Manhattan University. Notwithstanding the foregoing, Manhattan University reserves the right to deny admission under this Agreement in its sole discretion to any SCCC student who has a history of behavior which violates Manhattan University's Community Standards and Student Code of Conduct.

Scholarships

Transfer students admitted from SCCC who have earned a 3.0 cumulative GPA or higher will be automatically considered for, but not guaranteed, merit-based scholarships. Students must enroll at Manhattan University as a full-time, degree-seeking student and maintain a 3.0 GPA in order to renew any merit scholarship granted. The scholarship is renewable for up to two years or four semesters (fall and spring) of full-time coursework in a bachelor's degree program. Additionally, Manhattan University offers a limited number of Phi Theta Kappa (PTK)

scholarships. Scholarships cannot be applied towards housing, fees, summer session, or graduate tuition. SCCC graduates may also be eligible for state and federal aid and are encouraged to submit the FAFSA as soon as it becomes available.

Transfer of Credits

Students will receive a transfer credit evaluation within two weeks of admission, following Manhattan University's transfer credit policies, except that passing grades below C will not be accepted for SCCC graduates. Unless otherwise indicated in the course-by-course equivalency tables, 60 credits from the associate's degree will be applied towards the completion of a bachelor's degree program at Manhattan University. Courses for which the graduate did not achieve the minimum grade for the program will receive credit for the course; the Manhattan University program chair or their designee will determine whether the course can be applied to the program requirement, the Manhattan University core or as an elective. Wherever possible, course substitutions will be made for Manhattan University requirements to ensure maximum transferability of credit for SCCC students.

Financial Aid

SCCC students should file a FAFSA for the year they plan to attend Manhattan University. Within seven days of receipt of the FAFSA, Manhattan University will provide an offer of financial aid to admitted students.

Completion of Bachelor's Degree

Students who attend Manhattan University under this Agreement will be required to fulfill Manhattan University's bachelor's degree requirements from the academic catalog in effect during their first semester of matriculation. Students must meet Satisfactory Academic Progress as stated in the Manhattan University academic catalog.

Promotion and Outreach

Manhattan University and SCCC agree to publicize this Agreement through but not limited to print and digital marketing. Both institutions agree to collaborate to ensure successful transfer initiatives and to develop future partnerships. SCCC will host Manhattan University representatives, including admissions staff and faculty, on SCCC's campus in order for Manhattan University to promote its programs and this Agreement.

SCCC will provide its newly admitted students, currently enrolled students, and alumni with information about this Agreement and will also list Manhattan University in any publications and/or websites that refer to articulation agreements.

SCCC and Manhattan University grant a limited reciprocal license for each to use the name of the other educational institution for the purpose of joint promotion and advertisement of this specific agreement, provided, however, that any and all publications or advertisements promoting this program or using the name and/or logo of the other educational institution must be pre-approved in writing by authorized representatives of both parties. Neither party is authorized to use the other's name and/or logo for any purpose other than stated herein. SCCC and Manhattan University will communicate their marketing and promotion plan to each other to avoid duplication and to make effective use of promotion resources.

Review and Termination

- A. The initial term of this Agreement shall be five (5) years from the date it becomes fully executed by the parties and shall automatically renew on each anniversary thereof unless terminated in accordance with the provisions of this section.
- B. The Agreement may be terminated by either party for convenience upon a minimum of 90 days' prior written notice, provided that termination for convenience shall not take effect during a semester but only after the completion of a semester. This Agreement may be terminated by either party for cause, including loss of accreditation, immediately. Termination of the Agreement will not adversely affect any students currently enrolled at, or accepted to, Manhattan University at the time of termination, and any commitments already made to individual students will be honored in accordance with the provisions of this Agreement
- C. This Agreement may be amended or modified by the parties only in a writing signed by both parties. Neither this Agreement nor any rights or obligations hereunder may be assigned or transferred by either party without the prior written consent of the other party.
- D. Changes made to relevant curriculum at either SCCC or Manhattan University will necessitate review of the programs at both institutions to determine if modification of this Agreement is necessary. If deemed appropriate, a new agreement will be generated and signed. Curriculum changes by either SCCC or Manhattan University must be communicated in writing no later than June 30 of any academic year. SCCC and Manhattan University each assume responsibility for informing their students of curricular revisions that would impact student planning and/or degree completion.
- E. SCCC and Manhattan University agree to communicate program changes in a timely manner to avoid disruption of student progress toward degree completion.

XIII. Miscellaneous

Both Parties agree:

A. Confidentiality. During the course of performance of this Agreement, either party (the "Receiving Party") may be given access to information that relates to the other party's (the "Disclosing Party") past, present and future research, development, business activities, products, services, technical knowledge and personally identifiable student and employee information. All such information shall be deemed "Confidential Information" and marked as such unless otherwise indicated by the Disclosing Party in writing at or after the time of disclosure. Receiving Party may use the Confidential Information only in connection with the specific duties authorized pursuant to this Agreement. The terms of this Section shall survive the expiration or termination of this Agreement. Each party hereby acknowledges and agrees that the other party shall have the obligation to disclose only such information as is required by law and that any such

disclosure shall be limited to the extent that the Disclosing Party considers proper under the law. Notwithstanding the foregoing, MU acknowledges that SCCC is subject to the New York State Freedom of Information Law (Public Officers Law Article 6) and may be required to disclose information or records in response to a properly worded request. If either party is directed or ordered to provide or disclose any information or matter by public authority or otherwise required to do so by law, such party shall promptly notify the party whose information is being provided or disclosed.

- B. Each Party shall designate a representative who shall coordinate and monitor the Agreement.
- C. Compliance with Laws. Each party warrants on its behalf and that of its contractors, employees, and agents that it shall comply with all applicable Federal, New York State, and local laws, ordinances, rules, regulations, and codes. Each party further certifies that they do not have institutional policies or practices that fail to address the harassment and discrimination of individuals on the basis of their age, race, creed, color, national origin, sex, sexual orientation, gender identity, disability, martial status, military status, or other protected status under federal or state law or regulation.
- D. No Employment Relationship Created. It is understood and agreed between the parties that this Agreement is not intended to nor does it create an employment contract between Manhattan University, on the one hand, and SCCC or SCCC's employees, on the other, nor does it create a joint relationship or partnership between the parties hereto. The parties' relationship is solely and exclusively that of independent contractor. Except as specifically permitted in this Agreement, neither party shall use the name or trademarks of the other party or incur any obligation or expense for or on behalf of the other party without the other party's prior written consent in each instance.
- E. Force Majeure. Notwithstanding anything to the contrary contained in this Agreement, neither party shall be liable nor shall any credit or other remedy be extended, for such party's failure, in whole or in part, to fulfill its obligations under this Agreement where such failure arises from or in connection with causes reasonably beyond such party's control, including, but not limited to, acts of God, flood, extreme weather, fire or other natural calamity, terrorist attack, any law, order, or regulation or action of any governmental entity or civil or military authority, power or utility failure, cable cuts, unavailability of rights-of-way, national emergencies, riots, wars, strikes, lock-outs, work stoppages or other labor difficulties, or epidemics, pandemics, or other global health emergencies (each a "Force Majeure Event"). If a Force Majeure Event occurs during the term hereof, the materially adversely affected party(ies) shall be excused from performance hereunder for the duration of the Force Majeure Event.
- F. Severability. If a court holds any provision of this Agreement to be illegal, invalid, or unenforceable, the remaining provisions shall remain in full force and effect and the parties shall amend this Agreement to give effect to the stricken clause to the maximum extent possible.
- G. No Third-Party Beneficiary Rights. This Agreement is not intended to and shall not be

construed to give any third party any interest or rights (including, without limitation, any third-party beneficiary rights) with respect to or in connection with any agreement or provision contained herein or contemplated hereby, except as otherwise expressly provided for in this Agreement.

- H. Waiver. Failure of either party to enforce any of its rights hereunder shall not constitute a waiver of such right(s) or of any other rights and shall not be construed as a waiver or relinquishment of any such provisions, rights, or remedies; rather, the same shall remain in full force and effect.
- I. Governing Law and Jurisdiction. Except as may be preempted by federal law, this Agreement is governed by the laws of the State of New York, without regard to its choice of law principles. Litigation of all disputes between the parties arising from or in connection with the Agreement shall be conducted in a court of appropriate jurisdiction in the State of New York.
- J. Notices. Any notices must be in writing and will be deemed effective when: (a) delivered personally; or (b) delivered by reputable overnight courier with proof of delivery to the party and address set forth below or such other address(es) of which such party shall have given written notice. All notices to the institution in connection with this Agreement shall be sent to:
